## PTSU COLLECTIVE AGREEMENT SIGNING- UPDATE

Preparations for signing PTSU's 1<sup>st</sup> Collective Agreement are moving through the final steps! If all continues on this path, Agreement signing should take place before the end of June.

### ARE YOU A PTSU MEMBER IN A POSITION

#### WORKING IRREGULAR SCHEDULE(S)?

The 1<sup>st</sup> PTSU Collective Agreement has a Memorandum of Agreement (MOA) about terms and conditions of employment for **Employees with Irregular Schedules**. That MOA provides that, within 30 days of signing of the Agreement, the Parties shall form a committee to make recommendations with respect to terms and conditions of employment (hours of work, overtime, vacation, on-call, standby, and travel) for employees in positions within the MOA's scope. Those positions are:
